

### **EXPRESSION OF INTEREST FOR THE**

## DEVELOPMENT OF A SOLAR PHOTOVOLTAIC (PV) PLANT AT BITRI HEADQUARTERS IN GABORONE, BOTSWANA

#### **1.0 Background**

Botswana Institute for Technology Research and Innovation (BITRI) was established in 2012 as a Government of the Republic of Botswana company limited by shares, to conduct needs-based research and development in focused areas, in accordance with national priorities. BITRI is established under the Ministry of Tertiary Education, Research, Science and Technology (MOTE), with a Mandate to identify, develop and/or adapt appropriate technology solutions that provide sustainable innovative solutions through co-creation and collaboration in line with national priorities and needs of Batswana.

The Energy Division, under BITRI's Technologies Department, is mandated to develop and adopt Clean Energy Technologies for Botswana, as well as optimize existing ones. Through this project, the Division seeks to showcase how existing buildings can be retrofitted through redesign, incorporation of renewable energy and change of cultural practices to reduce their carbon footprint and lifetime costs of ownership. One of the key areas under consideration in this project is research and development on solar powered solutions, specifically the use of solar to substitute/augment grid electricity for day-to-day electricity use.

#### 3.0 Scope of work

BITRI is now issuing an Expression of Interest for experienced Solar Photovoltaic (PV) developers to finance, design, construct, operate and maintain a solar PV plant at the BITRI Headquarters under a Leasing Agreement for a period of 10 years.

100% Citizen-owned, PPADB Registered companies are invited to submit proposals to be considered for the design, financing, construction, operation, and maintenance of the BITRI Headquarters solar PV plant.

Eligible companies or consortia should prove their experience in the design, financing, construction, operation, and maintenance of solar PV plants as outlined in the eligibility criteria below. Only a single company or consortia will eventually be selected for this project.

# For the purpose of this Expression of Interest, a 0.4 MW Ground mounted Grid-tied Photovoltaic system shall be assumed.
